A discussion on resolution R-2, which involves the creation of annual board committees, was held. The nature of the Green Committee and recommendation to merge primarily into the Finance/Facilities Committee for efficiency reasons was highlighted. Other committees such as Education/Technology or Policy/Communications could review sustainability initiatives if their nature aligns with such. Board members and Dr. Hart shared their thoughts. Pros and cons were shared, with the primary concern of removal at this time impacting the current application for Sustainable Jersey as a critical component of that process to continue to be eligible for re-certification. All four schools and the district achieved silver recognition from Sustainable Jersey in prior certification efforts, the highest level feasible.
