Additions of "refer to appendix" to #2 and "centralized system and individual school" to #3. First read next board meeting.

Look into food option choices at all schools. Certain schools seem to come out on top. Perhaps more choices or additions at other buildings.

3. Update from Attorney:

Policy and Regulation 7441 – Electronic Surveillance in School Buildings and on School Grounds The purpose of the cameras is for school safety. Review of RTEA concerns and the communications between admin and RTEA from June, particularly the differences in the case of Belleville.

4. Strauss Esmay *Public Access Online Service* and users-search feature to be added so that policies can be easier accessed. Regulations would also be added as we assure they are up-to-date.

Small cost associated for the feature. 15 total employees currently have access to SE website, also at a cost per employee. Will easily be made up with elimination of unnecessary employee access and canceling unused accounts.
