Review of policy alert and policy guide.

- Policy 0169.02 Board Member Use of Social Networks
 Language used may contradict ethics training. Shelved until next meeting.
- Policy 3437 Military Leave and Policy 4437 Military Leave
 Defined District employment time to specify full time, meaning employed over
 one year. Originally anyone who serves could become eligible for leave even if
 worked only 1 month. First read at next BOE meeting.
- Policy 5460.1 High School Transcripts
 Discussion on whether it is applicable. Has no bearing on Readington. Though mandated, not for a K-8 district.
- Policy 5516.01 Student Tracking Devices
 Discussion on the language, populations that are being addressed, current policies that may address part of this. Shelved for discussion at next meeting.
- Regulation 7101 Educational Adequacy of Capital Projects
 Very few changes, language removed as per DOE. First read at next BOE meeting.
- Policy 7425 Lead Testing of Water in Schools
 Water tested last year before a policy was suggested over the summer. Followed
 State law at the time. Policy is suggesting testing every 6 years. We would like to see yearly. First read at next BOE meeting.
- Policy and Regulation 7440 School District Security

Do we have School Safety Specialist? Jason. Suggested that he be on committee but not specialist due to training regulations and what that would mean for time out of district. Dr. DeFabiis will be further exploring an appropriate candidate for this position. First read at next BOE meeting.
