- 1. Discussed Abolishing Residency <u>Policy 5118</u> and Use of School Facilities <u>Policy 7150</u>. Residency Policy 5111 and Policy 5118 were similar but had contradictory dates for when school tuition would be warranted, so the committee recommended abolishing Policy 5118. Policy 7150 seems to have been a typo at some point and covers the same items as our current policy 7510 Use of School Facilities.
