The New Jersey School Boards Association ("NBSBA"), as Lead Agency of the Alliance for Competitive Energy Services ("ACES") Cooperative Pricing System (System No. E88-01-ACESCPS), is pleased to award a contract for supply of natural gas supply service to South Jersey Energy Company as a result of bids received today, April 23, 2014. South Jersey Energy Company has submitted the necessary documentation required by the Request for Bids, thereby qualifying it to serve New Jersey's public school districts.

This Award Letter issued by the Lead Agency, in concert with Participating Member resolutions, constitutes a binding commitment of all districts with accounts in the awarded bid group(s) to execute the Model Supply Contract.
